

BY THE NUMBERS

We surveyed our attendees and faculty:

- **60**% of survey respondents plan to return to the in-person meeting in February
- Reach **1800** attendees (based on average numbers from 2019–2021)
- Network with specialists from around the world who are on the frontier of cancer research and clinical trials
- Bringing our working meetings to virtual audiences has expanded our reach to firsttime attendees. The number of registrants has doubled after bringing the meeting online
- Attendee disciplines and specialties from the Summer 2021 Meeting:
 - o 25% Clinical Trials & Clinical Research,
 - 19% Medical Oncology
 - 19% Radiation Oncology
 - 11% Obstetrics & Gynecology.
- Self-reported roles from Summer 2021:
 - 618 Physicians
 - 460 Clinical Research Coordinators
 - o 212 Clinical Oncologists
 - 153 Nursing
 - o 92 Admin/Management
- The 2021 virtual meetings brought an average of 175K Twitter impressions through the month of the meetings. Logo branding opportunities detailed below.


REGISTRANT DEMOGRAPHICS


The NRG continues to lead the way in cutting edge cancer development, research, and treatment. Our attendees choose our meetings to continue to learn about the latest developments and education in clinical trial development, providing opportunities to network with other professionals in their field, while earning continuing medical education accreditation.



25% of attendees from the Summer 2021 meeting stated their reason to attend was "To learn about current events and NRG trials." Nearly 20% attended to further their education in their respective fields. 15% stated they attended because they performed the role of clinical research coordinator at their institution.

First Time Attendees have consistently been high with the introduction of virtual meetings. Bringing the conference online has continued to bring new faces to our meetings.






The majority of NRG Oncology meeting attendees come from membership institutions within the United States. Canadian and international members make up 4% of our virtual audience.



EXHIBIT HOURS AND FAQ

REGISTRATION - All exhibitors must register as an exhibitor to receive name badges. Exhibitors are entitled to 3 complimentary badges per Exhibit Table. Additional badges are \$100 per person. Exhibitors can pick up their badges at the check-in kiosk located at: West 301A Lobby. Each exhibitor must name at least one person to be representative in connection with the virtual exhibit. Virtual exhibitors are invited to attend open sessions but must update their name in their video feed to indicate their company as well as their name. On-site exhibitors wearing a badge may attend and session not noted as 'Closed'. Additional representatives may register for an additional fee. Sharing of any log-in information to the NRG Oncology Winter Meeting with any non-registered person(s) is strictly prohibited and grounds for dismissal of exhibitor from the Winter Meeting. Exhibitors are expected to be familiar with and adhere to the NRG Oncology Anti- Harassment and Meetings Code of Conduct Policy as available. NRG Oncology will set up a registration management page for each exhibitor. Upon receipt of exhibit fee payment, a link to account creation and information regarding the number of complimentary registrations earned will be emailed to the exhibitor's registration contact which the exhibitor has provided.

Exhibit Installation Hours

Exhibit Set-up begins: 3:00 pm, Wednesday, February 9th, 2022 Exhibits must be dismantled by: 3:00 pm, Saturday, February 12th, 2022 Any charges for Shipping, Installation, and Dismantling are the responsibility of the Exhibitor.

SPACE - Rental of the space includes draped one (1) 6' x 30" table and two (2) chairs. The exhibitor is responsible for signage. Any internet connectivity or electrical needs are the responsibility of the Exhibitor. Information regarding these services will be provided after we have received your application. No exhibit shall interfere with another exhibit. Signs, motion pictures, public address apparatus, loud speaking records and tapes are not permitted without special permission.

SUBLETTING OF SPACE - Subletting of space will not be permitted. The principal exhibitor must sign the application for space. The principal exhibitor may not have materials, representatives or equipment from any organization other than their own.

HOTEL RESERVATIONS - All on-site exhibitors are responsible for making their own reservations. Reservations must be made via hotel link on the NRG Oncology Meeting Resources Exhibitor page by January 20th, 2022. For your convenience, all Continental Breakfast and Beverage Breaks will be held in the Exhibitor Display Area.

ELIGIBILITY - An organization that has a product or service that is related to the field of oncology is eligible to exhibit at the NRG Oncology Winter 2022 Meeting. NRG Oncology reserves the to accept or reject a potential exhibitor based on its assessment of whether that company or organization's products and/or services are relevant to NRG Oncology members/meeting attendees. All exhibitor applications must be approved by NRG Oncology in advance of the meeting.

DEMONSTRATIONS - Competent, well-informed demonstrators must be in charge of all exhibits and must be present during all intermissions.

LITERATURE FOR DISTRIBUTION - All new exhibitors must submit sample copies of all literature to be distributed, and must accompany the Application for Space, or be forwarded as soon as available to the Director of Exhibitors. NRG Oncology has the right to forbid distribution of any material.

COST - The cost of one (1) tabletop exhibit: \$3000.00 (If space is available) An additional table cost: \$1,000.00

All display material must be fire proof and subject to inspection by the local Fire Marshall. No flammable fluids or substances may be used.

EXHIBIT & SPONSOR POLICIES

SECURITY - Neither NRG Oncology nor the meeting facility will guarantee exhibitors against loss and will not be held responsible for loss of any material by or for any cause. Exhibitors must make provisions for safeguarding of their goods, materials, equipment, and display at all times. Exhibitors are encouraged to carry their own insurance through their own sources at their expense.

INSURANCE - It is the responsibility of each exhibitor to maintain insurance against injury, property damage, theft, fire, and any other forms of property loss or injury. NRG Oncology requires that all exhibitors maintain general liability insurance in the amount of \$1,000,000 and must name NRG Oncology as an additional insured for the period of Feb. 10th-12th, 2022.

PENALTIES - Failure to have an exhibit installed on time, to keep exhibit intact until closing time, or other infractions of the rules set forth in this Prospectus or established by the Convention Center may result in penalties prescribed by the Director of Exhibits.

CANCELLATION - In the event that the Winter 2022 Meeting is postponed due to any occurrence not occasioned by the conduct of NRG Oncology or Exhibitor, whether such occurrence be an Act of God or the common enemy or the result of war, riot, civil commotion, sovereign conduct, or the act or conduct of any third party, then the performance of the parties of their respective meeting obligations shall be excused for such period of time as is reasonably necessary after such occurrence to remedy the effects thereof. If the occurrence results in cancellation of the meeting, the obligations of the parties under applicable agreements shall automatically be terminated and all exhibit payments shall be refunded to Exhibitor, less a pro rata share of expenses actually incurred by NRG Oncology in connection with the meeting.

LIABILITY/HOLD HARMLESS - Exhibitor hereby agrees to and does indemnify, hold harmless, and defend NRG Oncology Foundation, Inc. ("NRG") from and against all liability, responsibility, loss, damage, cost or expense of any kind whatsoever (including attorney's fees), which may incur, pay or be required to pay, incidents, or indirect employee negligence, acts or omissions by Exhibitor/Attendees; and NRG and its respective agents or employees shall not be responsible for loss, damage or destruction of property.

NRG reserves the right without recourse to control or prohibit any exhibit or part of any exhibit that is contrary to the NRG mission and values. This includes the conduct of persons and the content of the exhibit. NRG may dismiss an exhibitor from the conference for unethical conduct. It is agreed that no refund of fees shall be made upon dismissal.

TERMS AND CONDITIONS - By submitting an exhibit application; I hereby authorize NRG to reserve exhibit space for use by my company or organization. I hereby acknowledge receipt of and agree to abide by these Exhibit Rules and Regulations. I agree to ensure all company representatives will be registered attendees and update their name to include company information. NRG reserves the absolute right, at any time, to determine the eligibility of any company or product for inclusion in the exhibit. I have signed the exhibit application indicating that I understand the rules and regulations.

Written requests for cancellation must be received by January 10th to receive a full refund, less a \$100.00 administrative fee. Any Cancellations after January 10th will receive a 50% refund, less \$100.00 administrative fee. There will be no refunds for any cancellations after January 30th.
